

Living Her Legacy Privacy Notice

This privacy notice discloses the privacy practices for (www.LivingHerLegacy.org). This privacy notice applies solely to information collected by this web site. It will notify you of the following:

- I. What personally identifiable information is collected from you through the web site, how it is used and with whom it may be shared.
 - A. We collect the information you share with us such as your name, email and USPO mailing address.
 - B. The information collected is kept in our Network For Good CRM/fundraising nonprofit support program.
 - C. We never share or sell any information provided to us that guests share to stay connected to our events, programs and/or speaker series.
- II. What choices are available to you regarding the use of your data.
 - A. Our guests who want to follow our progress always have the option to opt out.
- III. The security procedures in place to protect the misuse of your information.
 - A. The security procedures are provided by Network For Good as that is the company that provides our software CRM (Customer Relations Management) system.
- IV. How you can correct any inaccuracies in the information.
 - A. We can go into the CRM system and update or delete any guest information as needed or requested.
- V. How policy changes will be communicated.
 - A. Policy changes will be sent out via email newsletter updates.

Information Collection, Use, and Sharing

We are the sole owners of the information collected on this site. We only have access to/collect information that you voluntarily give us via email, text, QR code or other direct contact from you. We will not sell or rent this information to anyone. We collect with our donations the following information: name, mailing address and email. On our website for a landing page, we collect name and email address for most items, for our mailed USPO newsletters, fundraising letters, Thank you letters and/or if other mailings are needed to be sent we will collect your mailing address as well. We will use your information to respond to you, regarding the reason you contacted us. We will not share your information with any third party outside of our organization, other than as necessary to fulfill your request, e.g. to ship an order. In the future we will have books, journals and a few additional items for sale.

Unless you ask us not to, we may contact you via email in the future to tell you about new events, programs or speaker series or changes to this privacy policy.

Your Access to and Control Over Information

You may opt out of any future contacts from us at any time. You can do the following

at any time by contacting us via the email address or phone number given on our website:

- See what data we have about you, if any.
- Change/correct any data we have about you.
- Have us delete any data we have about you.
- Express any concern you have about our use of your data.

Security

We take precautions to protect your information. When you submit sensitive information via the website, your information is protected both online and offline.

Wherever we collect sensitive information (such as credit card data), that information is encrypted and transmitted to us in a secure way through our Network For Good CRM system. You can verify this by looking for a closed lock icon at the bottom of your web browser or looking for "https" at the beginning of the address of the web page.

While the Network For Good system uses encryption to protect sensitive information transmitted online, we also protect your information online and offline. Only nonprofit staff who need the information to perform a specific job (for example, billing or customer service) are granted access to personally identifiable information. The computers/servers in which we store personally identifiable information are kept in a secure environment.
